**Payment:** Please enclose a non-returnable deposit of 25% with this form. The balance is payable four weeks before arrival.

**Pets:** Well behaved pets by prior arrangement and subject to a £50 deposit against damage (refundable on departure).

**Short Notice Bookings:** Full cash payment is required on or before arrival.

**Short Breaks:** Low and Mid Season only and subject to availability.

**Electricity:** Electricity meters are read on arrival and read again before you leave. Electricity consumed is charged at standard Hydro-Electric unit rates on departure.

**Cancellation Policy:** The occasional cancellation is inevitable and we will do our best to minimise any cost to you if you **notify us of any cancellation as soon as possible**. We will endeavour to re-let the property and we will deduct the amount of any rent received from the balance due to us. Alternatively, subject to our prior approval, you may assign your holiday let to a third party. In all circumstances, we reserve the right to retain the deposit to defray additional expenses. Under cancellation for standard insurable risks (serious injury/illness/death, jury service, etc of a member or of your party) we will be pleased to consider placing your deposit against a letting at some later date.
